**There are three legalisation levels/ Postoje tri stepena legalizacije**

- 1.release of legalisation when only certification by public notary is necessary (when there is bilateral agreement with the Republic of Serbia) /  
*oslobođenje od legalizacije kada je potrebna samo overa javnog beležnika/notara (kada postoji bilateralni sporazum sa Republikom Srbijom)*
- 2.certification with Apostille seal (for the countries members of the Hague Convention) / *overa pečatom Apostillee (za zemlje članice Haške konvencije)*
- 3.certification of document at diplomatic and consular representative office of the Republic of Serbia (for other countries) / *overa dokumenta u diplomatsko-konzularnim predstavništvu Republike Srbije (za ostale zemlje)*
